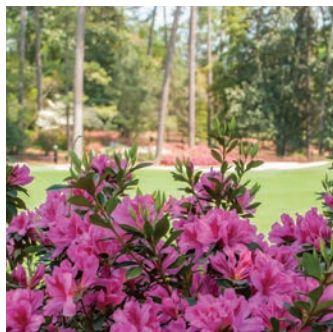
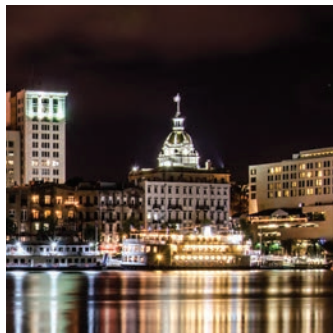

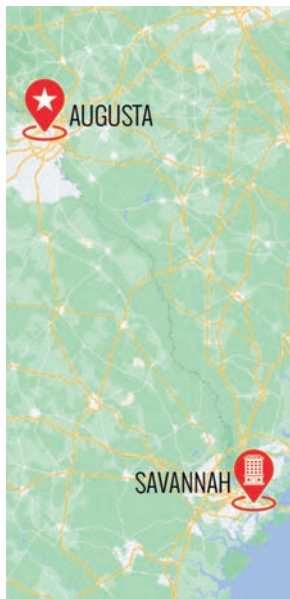

A non-refundable deposit per person will be due at the time of booking. Final payment will be charged to the card on file 90 days prior to the trip. Cancellations made before 90 days out will result in a loss of the tour deposit. All cancellations are non-refundable after final payment has been processed. Any cancellation request must be made to SET, LLC in writing.

Travel packages booked within 90 days of the package start date will require full payment upon booking and are non-refundable.

Reservations

All reservations will be confirmed on a first come, first-served basis and time stamped, if applicable. Guests will be mailed final documents to the address on file approximately one month prior to departure with important event details and package information.

Travel Insurance

SET, LLC strongly recommends that you purchase travel and cancellation insurance to protect your investment in the event of unexpected or unforeseen circumstances.

Rates

Program rates are based on minimum participation levels, current fares (air, water, land), tariffs, energy/fuel costs, and currency values. If the number of passengers falls below the minimum required, a surcharge may be imposed, or the tour may be canceled.

Itineraries

Tickets, accommodations, itinerary inclusions, events, travel directors or expedition leaders, and arranged excursions are subject to change at any time due to unforeseen circumstances or those beyond SET, LLC's control.
