- Participate in activities leading to and maintaining Tree Campus USA recognition
- Install and maintain irrigation systems.
- Pick up litter and empty trash cans on Campus.
- Assist in trenching, digging, and back filling of holes and ditches.

Other duties

 Any additional duties assigned by the Grounds & Athletic Fields Supervisor or the Director of Facilities Management.

Qualifications

Required

- Basic knowledge of Horticulture.
 - Basic knowledge of the maintenance of ground equipment.
 - Basic knowledge of turf grass maintenance.
 - Effectively and professionally communicate with co-workers, students, faculty, and

administration.

- Ability to sit, stand, walk, climb, bend, kneel and grasp for extended periods of time.
- Safely lift 80 lbs.
- Work extended periods of time in a non-environmentally controlled setting indoor and/or outdoor.
- High school diploma or GED.
- Must attend seminars and classes as deemed necessary by their supervisor.
- Experience operating push mowers, edgers, weeds eaters, and hand tools.
- Must possess and maintain a valid Oklahoma Driver's license.
- This position is designated as a safety sensitive position and employment is contingent upon results of a drug test based on OBU's Drug Testing Policy.
- This person will be required to work overtime, and or, adjust their schedule as needed when it is deemed necessary by their supervisor.
- This person must be willing to be subject to call at any time, day, or night.
- Must be an active member of a local evangelical church.
